## MEGHALAYA LEGISLATIVE ASSEMBLY BUDGET SESSION (BULLETIN) THURSDAY, THE 17<sup>TH</sup> MARCH, 2011.

The House met at 10.00 am with the Hon'ble Speaker in the Chair, and transacted business till 2:30 P.M. The day was allotted for transaction of Private Member's Business.

### 1. Questions:

Starred Questions No.84 to No.92 were taken up and disposed off.

#### 2. Zero Hour Notice:

Shri Ardent Basaiawmoit, MLA, submitted a Zero Hour Notice "Impact on Students community due to the traffic congestion along NH 44 on 17.03.2010". Shri Ardent Basaiawmoit expressed concern that many students today could not reach the examination hall of their respective schools due to the traffic congestion along NH 44.

Dr. Mukul Sangma, Chief Minister replied and said the schools will be directed to give extra time today for sitting in their examination today due to the traffic jam.

#### 3. Motions:

Shri Manas Chaudhuri, MLA, continued with his speech on Motion No.4, "This House do now discuss the need for enunciating a pragmatic State Youth Policy to meet the needs of our youth in the 21<sup>st</sup> century".

Shri B. M. Lanong, Deputy Chief Minister in-charge Sports & Youth Affairs replied. On the request of the mover, he also assured that a copy of Draft Youth Policy will be circulated to all the Members.

Shri H. S. Lyngdoh, MLA, moved Motion No.5 "This House do now discuss the present exploitation of the natural wealth of Meghalaya like the minerals, forest, etc, and to control the exploitation at once".

Shri B. M. Lanong, Deputy Chief Minister in-charge Mining & Geology replied.
